

**JEFF DAVIS COUNTY COMMISSIONERS COURT  
ORDER NO. 2020-05 SETTING 2020 TAX RATE  
AND LEVYING AD VALOREM TAXES**

Whereas, the Jeff Davis County Commissioners Court for 2020, in order to provide funds with which to meet the budget requirements of the County, and to pay the expenses necessarily incurred in connection with the services provided by the County to Jeff Davis County residents: therefore,

**BE IT ORDERED BY THE COMMISSIONERS COURT OF JEFF DAVIS COUNTY, TEXAS:**

1. That there is hereby levied and there shall be assessed and collected for 2020 ad valorem tax of \$.75062 per \$100 assessed valuation on all taxable property within the county as shown on the final approved 2020 tax rolls of the county.
2. THE TAX RATE WILL RAISE \$18,440 MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR. THE TAX RATE FOR 2020 IS THE SAME AS 2019, HOWEVER, MORE TAXES WILL BE RAISED BECAUSE THE CERTIFIED NET TAXABLE VALUE IS HIGHER THAN THE 2019 CERTIFIED NET TAXABLE VALUE. THE AMOUNT OF TAXES IMPOSED ON THE AVERAGE HOME WILL BE \$886.83.
3. This tax rate is hereby adopted in the following components:



4. That the Jeff Davis County Sheriff/Tax Assessor-Collector is hereby authorized and directed to prepare 2020 tax statements and transmit the same to the owners of taxable property within the County on or before October 1, 2020, or as soon thereafter as possible.




